Requests for a change in program option or payment plan must be submitted in writing. Approval of changes is subject to availability and the Director's discretion. Tuition fees are due 10 days after receipt of invoice. For payments delayed past their due date, your account will be charged a \$50 late fee at each occurence. If your child is withdrawn from school before July 31st, 2024, you will not be obligated to pay the total fixed tuition of \$16,200*. If your child is withdrawn between August 1st-31st of 2024, you will be obligated to pay the total fixed tuition of \$16,200* unless withdrawal is due to moving out of state, in which case, with proof of new residence, you will be obligated to pay 50% of the total annual tuition. In the event of withdrawal after August 31st, 2024, for any reason, you will be obligated to pay the remaining tuition amount for the 2024–2025 academic year. If suit or action by an attorney or collection agency is required to enforce collection, attorney or agency fees will be billed to your account.
